It was agreed that the Parish Council would present her with a leaving gift. Mrs Rix agreed to contact the headteacher for more details.

Mrs Rix also asked whether the Parish Council is aware of the status of the Meadowlea Children's Home. Councillor Steele agreed to make inquiries with Bradford Council's Children's Services.

#### 2024/114 To receive an update on the park and travellers' access

Councillor Banister gave an update. She has not yet received a response to her email to Brian Dobson about the proposals to restrict access. Councillor Steele agreed to chase this up.

#### 2024/115 To receive an update about the Welcome to Menston signs

An email had been received earlier in the day from Andrew Solomon. It was agreed to add this to the agenda for the next Parish Council meeting and Councillor White agreed to circulate the designs.

#### 2024/116 To receive updates about any recent meetings of the following groups:

- **Menston Community Association** Cheryl Thornton's proposal for a storage area for Community Association equipment is due to be discussed at the next meeting of the Kirklands Trust on 19<sup>th</sup> June.
- **Kirklands Menston Trust** Councillor White gave an update. The Trust are now considering the introduction of zoned heating by using smart thermostatic radiator valves and also the replacement of all the fluorescent tubes with LED lights.
- Climate Action Menston Councillor Banister gave an update. The AGM took place in May. Climate Action Menston and the Menston Community Association have now organised a Ladies Clothes Swap on 15<sup>th</sup> June at Kirklands.
- Wharfedale Greenway there was no update.
- Menston Parks Group Councillor Banister gave an update. A local resident had submitted an inquiry about the proposal to use rubber mulch as a safety surface in the play area. This inquiry has now been forwarded to Bradford Council for a response. There has been a delay in signing off the proposals for the new play area equipment and Councillor Steele agreed to chase this up. It was agreed that the Parish Council will provide an update for local residents on the Facebook page.
  Councillor Banister gave an update about the Peter Finlay memorial bench. She is now waiting to be put in touch with Peter Finlay's family to discuss the proposals.
  Councillor Steele gave an update about a proposal for the hire of the tennis courts in the park to be administered by the Lawn Tennis Association. The Parish Council were not in favour of this proposal and Councillor Steele agreed to take this up with Bradford Council.
